### Ogden Valley Land Trust Honors Former Board Chair Jody Smith: Says "Thank You" for a Job Well Done By Shanna Francis

Members of Ogden Valley Land Trust (OVLT) would like to recognize the efforts and contributions of former board chair Jody Smith, formerly of Eden. She was released from the position of chairperson in June 2016 after announcing that she and her husband Robert ("Bob")—who has also been a generous supporter of the land trust—were moving from the valley.

Jody came to Ogden Valley Land Trust May 14, 2008, first serving as the board's secretary. She was voted in as chair in 2011 at a board meeting held September 8, bringing to the position her signature drive, discipline, and leadership skills, which served the board well. Under her watch as chair, permanent conservation easements were placed on over 550 acres of land within the Middle Fork and Huntsville areas of the valley, a public wildlife trail was established in Eden, and she was also part of many successful fundraisers, raising money used to accomplish OVLT conservation goals.

Former board member Janet Muir stated, "Jody approached the task of chair of Ogden Valley Land Trust with energy, imagination, leadership and kindness. She got things done and inspired others to do the same. The years of baking a birthday cake for each monk at the monastery in Huntsville—almost all aged and quite frail—made her a legend at the monastery. And that kind of personal-touch generosity extended to the community and OVLT board members. I miss serving with her."

OVLT Board Treasurer Ruby Raccasi added, "Jody's leadership style was punctuated with her delicious homemade desserts and candy—her passion for the organization and her peanut brittle are legendary."

OVLT was established in April 1998 by a group of Valley residents interested in preserving Ogden Valley's character and valuable assets composed of pristine natural resources and unique scenic beauty. Concerned about the possibility of unchecked development in this historically agricultural community, founding board members felt that the most effective way to protect these vital assets was through the formation of a legally organized nonprofit land trust-Ogden Valley Trust-which now provides stewardship of easements that have voluntarily been placed on nearly 6,000 acres of now permanently dedicated open space in this unique mountain valley.

As Jody once wrote in an OVLT newsletter, regarding why someone might desire to place a conservation easement on their property, she stated, "How much do you like driving into the valley and seeing scenery instead of a zillion homes? How much do you like living in a place that doesn't have massive amounts of traffic? How much do you like breathing wonderful, clean air? How much do you like the rural and friendly community found in Ogden Valley? How much do you enjoy not having gridlock traffic? Ogden Valley Land Trust has something to offer—land protected in perpetuity."

Board members of Ogden Valley Land Trust recognize, with great appreciation, the tremendous amount of time and effort expended by Jody on behalf of this valuable non-profit organization, and extend a heartfelt "thank you" for the heroic contributions delivered to the community through, in large part, her efforts.

# Land Conservation in the News

Park City officials announced a \$38 million deal to buy and preserve Bonanza Flats, a 1,350-acre parcel rich in scenery, wildlife and wildflowers under Guardsman Pass that has long been eyed for a destination ski and golf development.

The land, located in Wasatch County along its borders with Summit and Salt Lake counties, would be the largest private inholdings ever acquired for preservation in the Central Wasatch, according to UOL (Utah Open Lands) executive director Wendy Fisher.

The acquisition, unanimously approved Thursday night by the Park City Council, would be financed in part by a \$25 million bond Park City voters approved

in November. Some of the balance would come from donations raised by UOL and other conservation groups that have joined forces to help conserve Bonanza Flats. The city has until March 15 to close the funding gap.
