# Highlights of 2019

#### **April: Monastery Documentary Preview**

Ogden Valley Land Trust partnered with Mountain Arts and Music to sponsor preview screenings of John Slattery's documentary film *Present Time: Journal of a Country Monastery* on April 19 and 20 at the Compass Rose Lodge in Huntsville, Utah.

Mountain Arts and Music had two goals for the event: first, to point to the unusual historical legacy of the monastery—a longtime Catholic organization in the midst of a mainly Latter-day Saint farming community, where it was embraced and integrated as a community icon; and second, to highlight the common values of working and loving the land that allowed that integration and how those values will be swept aside with unfettered development in the Valley. # The Makowski Conservation Trust

Ogden Valley Land Trust started receiving generous donations in 2018 from The Makowski Trust. In April 2019. we had the opportunity meet with representatives of the Trust-Ed and Heidi Makowski, to give them an overview of our organization, mission, accomplishments (including a tour of some of our easements), and plans for the future. The meeting also gave us a chance to find out more about them and Ed and Heidi provided the following information so that we could feature them in this, our current newsletter.

The Makowski Conservation Trust was founded by Edward Makowski's late brother, Kenneth Makowski, in 2016 and continues on in his legacy following his untimely death from pancreatic cancer at the age of sixty-one.

Ken had a strong love of nature, from the mountains to the beach, and he always planned to leave his estate to conservation organizations and to fund conservation work. He never expected it would happen so soon.

Ken was from New York and lived there most recently so the Trust is based in New York State. However, Ken loved the west, having lived for several years in the Seattle area at the beginning of his career with Microsoft, and he enjoyed skiing at many Utah resorts.

Ed & Heidi Makowski, Ken's brother and sisterin-law work to identify worthy conservation organizations in the west that fall within the Trust's mission and goals.

The mission of the Makowski Conservation Trust is to support conservation work and conservation organizations. The Trust has researched and identified many organizations in New York and across the country and in Utah worthy of support consistent with Ken's mission.

We are delighted to develop relationships with the Utah organizations that have received funding so far and work to identify new organizations in the surrounding states.

# Ogden Valley Land Trust Board of Trustees Says "Thank You"

The Ogden Valley Land Trust (OVLT) board would like to sincerely thank all who have supported the land trust throughout the 2019 year. Organizations like ours are completely dependent on community support and activism.

Our annual fundraising concert held August 10 was a tremendous success. In America, 4,000 acres of land are lost to development every day (Land Trust Alliance) and we lose nearly 40 acres of farmland every hour (American Farmland Trust). Once this land is developed it is gone forever. The projected rate of growth and new development potential in our valley, according to state statistics, is staggering and will have a profound effect on our community. Placing land in a conservation easement is a voluntary alternative way to benefit financially from land ownership while leaving a lasting legacy—preserving the agricultural resources, lifestyle, watersheds, wildlife habitat and natural landscapes and vistas we so dearly love here in the Valley.
